### **Individual Regulations (IREX) for the biennial One-frame Philatelic Exhibition with International Participation EnajstoOkno Kranj 2024**

#### **1. Name, Aims and Organizer**

The philatelic biennial One-frame exhibition with international participation **EnajstoOkno Kranj 2024** is organized by the Slovenian Philatelic Association (Filatelistična zveza Slovenije - FZS) and Gorenjski muzej in Kranj, to support this competitive way of exhibiting. It is open to exhibitors from all countries whose National Federation is a FEPA member.

#### **2. Venue and Date**

The venue of the exhibition EnajstoOkno Kranj shall be Gorenjski muzej in Kranj, Glavni trg 2. It shall be held from Thursday August 29 to Saturday September 7, 2024.

#### **3. Principles and Regulations**

EnajstoOkno Kranj 2024 shall be a competitive exhibition of Rank 1. Exhibits should be prepared in accordance with the General and Special Regulations of the FIP for the Evaluation of Competitive Exhibits at FIP Exhibitions (GREV and SREVs), FEPA Guidelines for narrow theme Exhibits in one, two, or three frames, **and** these Individual Regulations for the One-frame Philatelic Exhibition with Continental Participation EnajstoOkno Kranj 2024.

## **5. Conditions of participation**

Participation in the non-competitive part of the exhibition is subject to a special invitation at the discretion of the Organizing Committee.

In the competitive part, the participation is open to all collectors who are members of Philatelic Societies affiliated to the Slovenian Philatelic Association and all other National federations members of FEPA. Exhibits must have obtained on national and related rank exhibitions at least 70 points, new exhibits must be properly justified by the respective National Commissioner.

The entry form can be found at the FZS website: [www.fzs.si/enajsto2024](http://www.fzs.si/enajsto2024). Entry Forms must be received by either the Organizing Committee of the EnajstoOkno Kranj 2024 or the Commissioner General no later than **June 15, 2024**. Confirmation of acceptance will be sent out within July 15, 2024. Each collector can participate in the competitive classes with no more than two exhibits.

Exhibitors can display their exhibits in physical form or in digital form.

### **A. Exhibits to be shown in frames**

All exhibits will be shown **in one, two or three** 16 A4-sheet frames that can contain the following sheet sizes:

- 1) 210 x 297 mm (A4) and/ or
- 2) 420 x 297 mm (A3)
- 3) 310 x 297 mm (enlarged A4)

All sheets have to be progressively numbered. On the backside of the first sheet, the full name and complete address of the exhibitor should be written.

### **B. Scanned Exhibits**

All exhibit scans must be in JPEG format with 300 dpi quality. No other format or quality will be accepted. In the case of a sheet size of 210 x 297 mm (A4), the file size per page should not exceed 1 MB. In case of sheet size 420 x 297 mm (A3) or 310 x 297 mm (enlarged A4) the file size per page should not exceed 2 MB. The file name corresponds to the numbering of the exhibit list, as follows:

Page size 210 x 297 mm (A4): numbering 1-16/32/48

Page size 420 x 297 mm (A3): numbering 1-8/16/24

Page size 310 x 297 mm (enlarged A4): numbering 1-12/24/36

Each page should be named according to last name\_page-number.jpg as a filename. If the author has more than one exhibit the filename should be in the format lastname\_exhibit\_page-number.jpg

The text of the exhibits can be in one of the FIP languages or in Slovenian.

The Organizing Committee has the right to reject any exhibit without giving reasons for the rejection.

## **6. Obligations and Rights of Exhibitors**

The frame fee for all classes is 20 € per frame (physical or digital scanned exhibits). By signing the entry form, the exhibitor accepts the provisions of all regulations listed in Article 3. Each exhibitor must deliver his accepted exhibits to the Organizing Committee or to the Commissioner General in due time.

Each exhibitor will be entitled to one copy of the Exhibition Catalogue, the corresponding diploma and the participation to the Palmares ceremony.

The Organizing Committee has no obligations regarding possible National commissioners.

## **7. Awards**

The Jury, appointed by the Executive Committee of FZS, is in principle formed by international (FIP, FEPA) jurors. The exhibits will be evaluated according to the rules adopted at exhibitions under FEPA or FIP patronage.

The Jury can allocate the following awards, appropriate to a Rank 1 exhibition:

- Diploma equivalent to gold medal for 85 to 100 points
- Diploma equivalent to large vermeil medal for 80 to 84 points
- Diploma equivalent to vermeil medal for 75 to 79 points
- Diploma equivalent to large silver medal for 70 to 74 points
- Diploma equivalent to silver medal for 65 to 69 points
- Diploma equivalent to silver bronze medal for 60 to 64 points
- Diploma equivalent to bronze medal for 55 to 59 points
- Diploma of participation for less than 55 points.

The Jury can also allocate the following prizes:

- Grand Prix of the exhibition
- Special Prize
- Special Recognition

The decisions of the Jury are final.

The results will be published on the website of the exhibition on September 10, 2024, and the Organizing Committee of the exhibition will inform each candidate by e-mail.

## **8. Delivery and Return of Exhibits, Security**

All exhibits delivered by mail must reach Commissioner General Veselko Guštin at his address no later than August 17, 2024. Exhibits delivered by possible National Commissioners or by the exhibitor himself must be consigned at the exhibition venue no later than August 28, 2024 between 9.30 a.m. and 12 a.m.

The exhibits will be mounted and dismounted under the supervision of the Organizing Committee and, if the case, in presence of the related National Commissioner or exhibitor. After the end of the exhibition, the exhibits will be ready for personal consignment half an hour after the closing of the exhibition.

The costs of returning the exhibits by mail (DHL) will be borne by the Organizing Committee.

The Organizing Committee will take all reasonable precautions to ensure the security and safety of all exhibits whilst they are in its possession. The Organizing Committee, however, will not be liable for possible damage or loss of the exhibits. An insurance against such cases should be the responsibility of each exhibitor.

## **9. Submission of the digital scanned exhibits**

The exhibitor is obliged to submit the exhibit in the required jpg format and in the required 300 dpi quality using We transfer. Please visit the web page <https://wetransfer.com>. Drag and drop your files to the web page at "Add your files". Enter the given email of the Commissioner general, your email, and write a message. The message should consist of your name, exhibit title, and the competition class. The confirmation of receipt will be sent after the download of your files.

No editing/alteration/modification of the scanned items in any manner will be allowed or accepted.

The deadline to send your scanned exhibit is August 15, 2024.

## **10. Availability of the exhibits for the public**

The online format of the exhibition will be available via the internet ([www.fzs.si/EnajstoOkno](http://www.fzs.si/EnajstoOkno)) and in that sense the organizer is not responsible for copying, duplicating, or further use of the scanned pages of the exhibition or any part of it.

The organizer – FZS (Slovenian Philatelic Association) - will save all participating exhibits in the archives of its website, if the exhibitor agrees with that.

## **11. Supplementary Regulations**

The Organizing Committee of EnajstoOkno Kranj 2024 has the right to make changes to these Special Regulations if deemed necessary. The decisions of the Organizing Committee are final.
